**SESSION PAYMENT PLAN OPTION**- Swimmer's who would like to sign up for specific sessions may do so. This option does not include USA Swimming registration, bathing suit or club t-shirts, unless you are committing to the entire 05-06 payment plan and total amount due. You must state your intentions on the registration form.

**NOTICE OF SESSION PAYMENT PLAN OPTION**- Session Payments renew automatically and must be paid via credit cards. Credit cards will be charged two weeks prior to the beginning of the next session. Credit Cards must be on file with NSSC.

**NOTICE OF ESCROW ACCOUNT RENEWAL**: Escrow accounts will renew automatically on a session to session basis with the escrow account being charged to a positive \$100.00 balance.

**NOTICE OF PROGRAM CANCELLATION**- Credit Cards will be charged two weeks prior to the beginning of the next session, unless written notification of cancellation is given to NSSC prior to the charging of your credit card. If written notification of cancellation is given after the charge of the credit card, you will be responsible for the charged amount for the session.

**NOTICE OF INSURANCE**-Athletes must be registered under the North Shore Swim Club, USA swimming umbrella, if they plan to attend swim meets. This is a once per year fee. Non Competitive swimmers of the North Shore Swim Club must be registered under the North Shore Swim Club, non competitive umbrella. This is a per session fee.
